# **QUARTERLY MEETING – January 14,2000**

Bacone College Muskogee, Oklahoma

Chief Jerry Haney called the meeting to order at 9:15 a.m. with the Seminole Nation Color Guards presenting the colors and Reverend Bertram Bobb offering the invocation. Roll call was conducted by Loretta Finkenberg, Recording Secretary. A quorum was established with 23 answering roll call.

Motion received to approve Terri Haney as Treasurer by Toby Wise, seconded by Pat Woods and that the nominations cease. Terri Haney elected by acclamation.

**Indian Health Service** – Chuck Grimm, Acting Area Director for Indian Health Service-Oklahoma City Area Office, addressed the Council regarding re-authorization of the Indian Health Care Improvement Act, activities of the Senate Committee on Indian Affairs, and a National Diabetes Prevention Center.

Robert Harkey addressed the Council regarding unanimous support for the 1947 Act.

Oklahoma Indian Affairs Commission – Barbara Warner updated the Council on various issues.
