### **QUARTERLY MEETING – 04-19-01**

Fountainhead Resort Eufaula, Oklahoma

#### **E. AGENCY REPORTS:**

**Bureau of Indian Affairs – Franklin Keel, Acting Area Director.** Introduced are superintendents present. Announced 2003 budget meeting. Discussed ongoing trust reform.

**Indian Health Service** – **Chuck Grimm, Area Director** – Oklahoma City Area Office. Introduced Steve, Barse, new Public Affairs Specialist for HIS. Reported on Consultation meetings held across the country. Thanked chiefs and their staffs for serving on committees. \$180 million still to be given out. Oklahoma could get one-third of that. \$100 million added to Contract Health Service budget. 2002 Budget released 10 days ago with \$165 million increase.

**HUD** – **Wayne Sims.** Introduced Gary Tillotson. Discussed SuperNOFA and the funding opportunities available. CDBG - \$500,000 increase in this year's budget. 2001 Indian Housing Plans due July 1. 2000 Annual Performance report are now past due. IHP training next week in Oklahoma City – April 24-26.

**Barbara Warner** – **Oklahoma Indian Affairs Commission.** Reported on several issues including: the nomination of Neal McCaleb, the upcoming Sovereignty Symposium to be held in June, sales tax issue, Federal Unemployment Tax Act, and Oklahoma Lottery Act.

Next meeting will be held in Durant in July, 2001 and will be hosted by the Choctaw Nation. Chief Pyle adjourned the meeting at 12:05 p.m. and Rev. Bertram Bobb gave the benediction.
