## **QUARTERLY MEETING – April 7, 2000**

Pontotoc County Agriplex Ada, Oklahoma

#### **D. AGENCY REPORTS:**

**Bureau of Indian Affairs – Dennis Wickliffe.** Reflected on history of Inter-Tribal Council and congratulated them on their 50 year anniversary. Announced resignation of Hilda Manuel and appointment of Sharon Blackwell, effective April 7, 2000. BIA office is still in federal courthouse, but hopes to be in new office by Nov. 1. More information has been requested for candidates for Area Director. Self-governance conference in Tulsa the week of April 17. Two new federally-recognized tribes in Eastern Oklahoma region for FY'2001 are Seneca-Cayuga and Quapaw. National BIA budget meeting will be in Tulsa May 31-June 1.

Indian Health Service – Chuck Grimm, Acting Area Director for IHS – Oklahoma City Area Office. Tribal representatives selected to go to national budget hearings are Leonard Harjo and Mickey Peercy. Budget formula has not been equitable to Oklahoma in the past. Diabetes grant funds (third year of grant); notice of grant awards sent last week. Chickasaws and Choctaws passed GCAHO accreditation visits recently. Self-governance pre-negotiation meetings are May 9. Oklahoma City Area Office is being redesigned and will be completed shortly. Health summit will be held in Tulsa on August 15.

**HUD** – **Wayne Sims** reported to the Inter-Tribal Council on HUD programs. ICDBG Notice of Fund availability published on March 10. Will begin accepting applications on May 24. Extended congratulation on 50<sup>th</sup> anniversary of Inter-Tribal Council. Special Needs Housing workshop on April 12-13. Deadline for Indian Housing Plans is July 1, 2000. 1999 Annual performance reports are now due. Training workshop are being scheduled. Training for changes to lead-based pain regulations. 6<sup>th</sup> annual Native American Housing Summit to be held May 1-3 in Portland.

**Barbara Warner – Oklahoma Indian Affairs Commission** brought the Council up to date on legislative and other issues.

Chief Pyle dismissed the meeting at 12:15 p.m. and Rev. Bertram Bobb gave the benediction.
