# Supporting the National Association of Area Agencies on Aging and National Conference in Tulsa, July, 1998

The National Association of Area Agencies on Aging is a strong and avid supporter of the tribal elderly programs, and

#### WHEREAS,

The Nation Title VI Grantees Association has two members on the National Association of Area Agencies on Aging Board, and

#### WHEREAS,

The Inter-Tribal Council of the Five Civilized Tribes has a tribal member on the Nation Association of Area Agencies on Aging Board, and

#### WHEREAS,

The Oklahoma Aging Network, including the Oklahoma Indian Council on Aging, has supported the coordinated efforts of our board member, Tulsa Chamber of Commerce and the Adams Mark Hotel to successfully bid for this national conference, and

#### WHEREAS,

The National Association of Area Agencies on Aging and National Conference has never been to Oklahoma, therefore, the National Association of Area Agencies on Aging Board will be working with a committee comprised of the Oklahoma Aging Network.

## NOW, THEREFORE, BE IT RESOLVED,

The Inter-Tribal Council of the Five Civilized Tribes supports the National Association of Area Agencies on Aging Conference coming to Tulsa, Oklahoma, July, 1998, and supports its tribal members and staff in their endeavor to make the National Association of Area Agencies on Aging's Conference welcome to Oklahoma.
