**A RESOLUTION IN SUPPORT OF LEADER ASSOCIATES IN THEIR
SUBMISSION OF A PROPOSAL TO ADMINISTRATION FOR NATIVE
AMERICANS TO PROVIDE TRAINING AND TECHNICAL ASSISTANCE TO
ANA GRANTEEES**

WHEREAS,

the Inter-Tribal Council of the Five Civilized Tribes is an organization which unites the tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek), and Seminole Nations, representing over 300,000 Indian people throughout the United States, and

WHEREAS,

The Five Civilized Tribes of Oklahoma are responsible for providing for the health, education and general welfare of their respective constituencies, and

WHEREAS,

The Administration for Native Americans is inviting proposals for Training and Technical Assistance (T/TA) for current and prospective grantee organizations of the Administration for Native Americans, and

WHEREAS,

Ms. Carol L. Nuttle, President of Leader Associates, an American Indian Development firm, is submitting a proposal in response to ANA's Request for Proposals to be received no later than August 10, 1998, and,

WHEREAS,

Ms. Nuttle has worked extensively with Oklahoma tribes on state, national issues affecting social, economic and governmental self-determination, and

WHEREAS,

We believe that Carol L. Nuttle has the qualifications and experience to carry out ANA's charge to assist current and prospective ANA grantee organizations to develop quality community-based proposals for submission to the Administration for Native Americans in pursuance of community-based goals.

NOW, THEREFORE, BE IT RESOLVED,

That the Inter-Tribal Council of the Five Civilized Tribes of Oklahoma hereby endorse Ms. Nuttle of Leader Associates to serve the ANA Region II which includes the State of Oklahoma for the provision of Training and Technical Assistance for current and prospective organizations of the Administration of Native American programs.

The foregoing resolution was adopted by the Inter-Tribal Council of the Five Civilized Tribes meeting in Checotah, Oklahoma on July 10, 1998, by a vote of 25 for, 0 against and 0 abstentions.
