WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes (ITC) is an organization that unites the tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek), and Seminole Nations, representing more than 650,000 Indian people throughout the United States; and,

WHEREAS, the Standing Rock Sioux Tribe has been fighting the placement of the Dakota Access Pipeline across their ancestral lands in North Dakota; and,

WHEREAS, after a federal judge denied the Standing Rock Sioux Tribe's motion to stop the Pipeline, the Department of Justice, Department of the Army, and the Department of the Interior issued a joint statement announcing a temporary halt to work on the pipeline; and,

WHEREAS, ITC firmly stands in solidarity with the Standing Rock Sioux Tribe; and,

WHEREAS, ITC firmly believes that tribal nations across Indian Country have an inalienable right to self-determination of their tribal homelands; and,
