WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes (ITC) is an organization that unites the tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek), and Seminole Nations, representing approximately 750,000 Indian people throughout the United States; and

A Resolution to Support the Equal Treatment of Tribal Law Enforcement Agencies
Under Federal Law

WHEREAS, tribal law enforcement agencies are critical protectors of public safety in many communities; and

WHEREAS, tribal law enforcement agencies, like non-tribal law enforcement agencies, require appropriate equipment to properly do their jobs and protect their citizens; and

WHEREAS, the National Firearms Act of 1934, the Gun Control Act of 1968 and the Firearms Owners Protection Act of 1986 exempt non-tribal law enforcement agencies from onerous transfer taxes and prohibitions against the interstate shipment of firearms and the possession of certain weapons; and

WHEREAS, the exemption contained in the Firearms Owners Protection Act of 1986 is written to encompass "the United States or any department or agency thereof, or a State or a department, agency, or political subdivision thereof"; and

WHEREAS, because tribes and their law enforcement agencies are not part of, or agencies of, the United States government, or of a state government or a political subdivision of a state, tribal law enforcement agencies generally do not qualify for these exemptions; and

WHEREAS, in order to obtain this equipment, tribal law enforcement agencies depend on a palliative fix that was put in place by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) that requires tribal law enforcement agencies to take additional steps to become a federal subdivision that are not required of any other law enforcement agency; and

WHEREAS, these steps are burdensome and create inequity between tribal and non-tribal law enforcement agencies; and

WHEREAS, tribal law enforcement agencies should not be required to take steps that non-tribal law enforcement agencies are not required to take; and

# The INTER-TRIBAL COUNCIL of the FIVE CIVILIZED TRIBES

WHEREAS, a permanent fix is needed to ensure tribal law enforcement agencies have swift and proper access to this life-saving equipment; and

WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes previously endorsed the need for a permanent fix in 2014 through Resolution No. 14-12.

NOW, THEREFORE LET IT BE RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes strongly supports any and all legislative and administrative efforts to remedy this unequal treatment of tribal law enforcement agencies.

BE IT FURTHER RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes requests that our Congressional delegation work to develop legislation that would permanently place tribal law enforcement agencies on equal footing with non-tribal law enforcement agencies.
