WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes (ITC) is an organization that unites the tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek) and Seminole Nation, representing approximately 815,000 Indian people throughout the United States; and

WHEREAS, the ITC represents descendants of tribal nations and ancestors who survived and rebuilt thriving Nations after years of the Trails of Tears; and

WHEREAS, Fort Smith, Arkansas is an entry point and gateway to what became Indian Territory and what is now home to the five tribal nations of Cherokee, Chickasaw, Muscogee (Creek), Seminole, and Choctaw Nations. It was the entry to what our Nations became and also serves in modern-day as an important economic hub for commerce and health services; and

WHEREAS, the National Historic Site in Fort Smith serves as an important location for our Nations and visitors from around the world to tell our shared history in this region. It is an official stop on the Trail of Tears National Historic Trail. This location is one of the premier cultural and historic attractions in Arkansas and draws thousands of visitors annually to educate on our shared tribal, cultural, and judicial history; and

WHEREAS, the National Historic Site in Fort Smith also holds special significance to the Choctaw and Cherokee Nations, as it is the home of the boundary marker delineating our reservation boundaries. This official boundary marker predates statehood for both Arkansas and Oklahoma and reaffirms treaties establishing our reservations; and

WHEREAS, appropriations or budget reconciliation measures that reduce funding for the National Park Service threaten to diminish the importance of the site. Reductions in funding would jeopardize the interpretive services that educate the public about this critical history and would weaken the agency's ability to serve as living bridge between past and present.

WHEREAS, preserving this site is essential to protect historical accuracy and for the ongoing reconciliation and respect for which tribal nations and the City of Fort Smith strive in tribal partnerships and sharing our collective histories and future.

The INTER-TRIBAL COUNCIL of the FIVE CIVILIZED TRIBES

NOW THEREFORE LET IT BE RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes supports continuance of the Fort Smith National Historic Site under operation of the National Parks Service as a location of national economic and historical significance to tribal nations, tribal citizens, the states of Arkansas and Oklahoma, and the United States of America; and





The Chickasaw Nation




