WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes (ITC) is an organization that unites the Tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek) and Seminole Nation, representing approximately 877,000 Indian people throughout the United States; and

WHEREAS, the U.S. Department of Justice (DOJ) established the Tribal Nations Leadership Council (TNLC) in 2010 as a formal advisory body of Tribal leaders from across the United States to provide guidance and perspective to the DOJ on matters of tribal justice, public safety and federal-tribal relations; and

WHEREAS, the TNLC plays a critical role in facilitating government-to-government communication between the DOJ and Tribes, ensuring that federal policy and programmatic decisions are informed by tribal priorities; and

WHEREAS, the Eastern Oklahoma Region seat on the TNLC is currently vacant, and it is in the interest of the Tribal governments in Eastern Oklahoma to ensure continued representation on the TNLC; and

WHEREAS, the ITC has identified a Tribal leader to serve as the region's representative, selecting Principal Chief Chuck Hoskin, Jr., of the Cherokee Nation to serve as the region's representative on the TNLC;


NOW THEREFORE LET IT BE RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes endorses the nomination of Principal Chief Chuck Hoskin Jr. to serve as the Eastern Oklahoma Region Representative on the U.S. Department of Justice Tribal Nations Leadership Council; and

BE IT FURTHER RESOLVED, the Inter-Tribal Council of the Five Civilized Tribes urges the U.S. Department of Justice to confirm Principal Chief Hoskin Jr.'s appointment in order to ensure continued representation and advocacy for Eastern Oklahoma Tribal governments in federal justice and public safety policy development.


CERTIFICATION


